AWA audits, certifies, and promotes independent family farmers across the US and Canada who raise livestock outdoors on pasture or range, using truly sustainable agriculture methods. AWA is the only farm certification that guarantees animals are raised outdoors on pasture or range for their entire lives on an independent family farm using truly sustainable agriculture methods. No other food label offers these distinctions. AWA is one of only two certifiers in the US to require audited, high-welfare transport and slaughter practices. AWA is also the only welfare certification in the US offered by an organization accredited to ISO 17065, providing the highest level of oversight and scrutiny.
