NORTHWEST TASMANIAN FARM ACHIEVES RENOWNED ENVIRONMENTAL, ANIMAL WELFARE, GRASSFED AND NON-GMO CERTIFICATIONS

Respected Gunningham Family Farms is now Certified Animal Welfare Approved and
 Certified Grassfed for their dairy and beef cattle, sheep and goats and Certified Animal
 Welfare Approved for their laying hen operation, and will host a Grassroots Festival in
 February 2024 to promote sustainable agriculture—

MAWBANNA, TASMANIA (20 SEPTEMBER 2023)—The dairy and beef cattle, laying hens, sheep and goats at Gunningham Family farms are now Certified Animal Welfare Approved by <u>A Greener World</u> (AGW). Situated near Mawbanna on the northwest coast of Tasmania, Gunningham Family Farms has met the AGW programme standards, which were developed in collaboration with scientists, veterinarians, researchers and farmers across the globe to maximise practicable, high-welfare farm management.

The <u>Certified Animal Welfare Approved (AWA) by AGW</u> label verifies that animals are raised outdoors on pasture in accordance with world-renowned welfare standards using sustainable agriculture methods on an independent farm. Recently launched in Australia, AWA is part of the suite of "Certified By" seals offered by respected international certifier A Greener World, along with <u>Certified Grassfed by AGW</u> and <u>Certified Non-GMO by AGW</u>, which are optional, additional accreditations for Certified AWA farms.

Matthew and Pippa Gunningham established Gunningham Family Farms in early 2001, shortly after migrating from the UK to Tasmania. The farming family business is located on a magnificent swathe of beautiful, rich farmland along the edge of the Tarkine, an extraordinary and relatively untouched protected region.

The business comprises two certified organic dairy herds, Mawbanna Dairy near Mawbanna and Seamont Dairy near Montumana, each milking around 700 New Zealand Jersey-Friesian cross cows; a 400 Angus beef suckler herd; a small flock of sheep; and a small number of goats and pigs – all raised outdoors on pasture. Gunningham Family Farms' Certified Animal Welfare Approved and Certified Grassfed by AGW milk is supplied to the Fonterra Australia organic milk pool for Bellamy's Organic Infant Formula, while the beef cross calves are sold to other farmers locally. The Gunninghams also run a 3,000-bird flock of pasture-raised laying hens in mobile coops, selling eggs locally under the popular Shakespeare Hills Eggs brand, named after the Shakespeare Hills that surround and divide the two farms. (Lamb and pork is for home consumption and for on-farm events.)

As well as being Certified Animal Welfare Approved by AGW, the dairy and beef cows, sheep and goats at Gunningham Family Farms are also Certified Grassfed by AGW. This grassfed label guarantees a 100 percent grassfed diet, audited on an ongoing basis to ensure farms are meeting rigorous animal welfare standards. The dairy and beef cows, chickens, sheep, and goats are also Certified Non-GMO by AGW. This certification is an optional, additional accreditation for farmers meeting Certified Animal Welfare Approved by AGW standards of production and offers assurance of high-welfare and non-GMO farming practices, without genetically engineered/modified feed, supplements or ingredients.

The Certified Animal Welfare Approved by AGW dairy and beef cows, chickens, sheep, goats and pigs at Gunningham Family Farms are raised outdoors on species-rich pasture using rotational management, grazing and ranging on one area of pasture before being moved to fresh fields. As well as allowing the animals and birds to express all their instinctive behaviours, this type of management allows pasture to recover before the animals return, ensuring the most nutritious grazing is available. It also helps to keep the soil naturally fertilised and minimises the build-up of internal parasites, further avoiding reliance on chemical interventions.

The Gunninghams are actively planting trees, establishing over 40,000 trees in the last three years alone, and the farm is often used as a Farm Forestry Demo site to highlight the benefits of planting trees to other farmers and encourage similar practices. They also regularly host community events at the farm and are planning a Grassroots Festival in February 2024 to promote sustainable and ecologically positive agriculture, with a mixture of speakers and practical demonstrations from soil health to human health.



Sustainability sits at the very heart of the farm business and Matthew and Pippa are passionate about farming alongside – and not against – nature. With the growing disconnect of consumers from the source of their food and increasing demand for meaningful welfare standards, the Gunninghams found it essential to have third-party validation demonstrating their exceptional welfare and environmental practices to a market hungry for honest information about their food.

Matthew Gunningham of Gunningham Family Farms says,

"Consumer interest in the environment and animal welfare is growing exponentially. Our customers are increasingly concerned about the use of synthetic nitrogen, herbicides, and pesticides in many farming systems, as well as things like growth hormones and routine antibiotics in intensive livestock production. They want to buy food they can trust from farms that are manging their land and animals with the environment and animal welfare in mind."
