Auditor Job Advertisement – Multiple Positions Available

A Greener World (AGW) is growing our team and seeking multiple individuals to conduct audits of operations for AGW certification programs. AGW is a globally impactful nonprofit that identifies, audits, certifies and promotes practical, sustainable farming systems by supporting farmers and ranchers and informing consumers.

- **Certified Regenerative by AGW Auditors and Plan Reviewers; and**
- **Animal Welfare Approved Auditors and Slaughter Specialists**

Auditors complete species-specific reports detailing the operator's compliance with applicable standards. Audited scopes include crops, wild harvested products, and further processed products. Audited species include dairy cattle, beef cattle, bison, pigs, goats, sheep, chickens (laying hens and broilers), turkeys, geese and ducks. . Auditors with a Regenerative specialty may also act as Plan reviewers to review an operations plan or other documents, including conducting risk analysis for Certified Regenerative by AGW to determine suitability for audit.

Slaughter Plant Specialists review Slaughter Plants used by certified operations to verify suitability for use for applicable AGW programs.

Candidates with any one or more of the areas of expertise above will be considered. We are specifically seeking auditors for our Certified Regenerative by AGW program who have broad knowledge of both organic and conventional systems and who are familiar with different livestock and crop production practices, nutrient management, insect and weed control, irrigation, organic and non-organic inputs, and integrated production systems. Initial and ongoing training is provided, but a foundational and practical understanding of agricultural systems is necessary.

This position requires extensive travel across the United States and Canada. These positions are very flexible and can accommodate most schedules.

Contract rates start at \$300 for AWA audits and slaughter reviews and \$600 for Regenerative audits. Annual salary for full-time employees starts at \$54,000+ depending on experience, with health and dental insurance, retirement plan with employer match up to 3%, short- and long-term disability insurance and generous paid time off.

Requirements:

- Must have demonstrated experience in the area for which they are applying. Experience in auditing is a plus but is not required.
- Must be able to cover travel expenses for reimbursement.
- Good communication skills, especially the ability to communicate well with and maintain respectful attitude towards clients and staff.
- Ability to communicate in both English and Spanish is a plus but is not required.
- Valid driver's license and ability to lift 50 lbs.
- Ideal candidates will live close to a major airport, enjoy traveling and have good computer skills.
